#### **Glenolden Park Project**

The additional funding request was submitted to OHCD and we are awaiting County Council's decision. Construction is underway. We met with the Borough Manager and contractor at the site on August 2 and reviewed the scope of work items in the contract. Minor revisions were made resulting in combining the 2 play surface areas for the music/alphabet panels and the disc swing into 1 play area, reducing the asphalt walkway near these areas and adding new timber edging around the perimeter of the swing-set area. The revisions result in a reduced contract amount of approximately \$2,000.

#### MS4

The draft PRP prepared by the Eastern Delaware County Stormwater Collaborative was reviewed and presented. Glenolden Borough is one of ten communities who have joined together for the preparation

and implementation of the plan. The Borough represents just under 11% of the total sediment loading in the Darby Creek Watershed. Much like the arrangement with the Muckinipates Sewer Authority for sanitary sewers, the Borough will be responsible for their proportionate share of the costs for implementation. The Collaborate intends to seek grant funding to alleviate costs to the individual communities. The Collaborative & Borough have posted the Pollution Reduction Plan on their respective websites and a meeting of the Collaborative is scheduled for Wednesday, August 15<sup>th</sup> at 4:00 PM at Darby Township offices to solicit public input.

We are also preparing the Notice of Intent (NOI) to renew the permit from March 2018 through 2023 which is due to the Pennsylvania Department of Environmental Protection by September 16, 2017. A filing fee in the amount of \$500.00 is required with a check or money order made payable to the "Commonwealth of Pennsylvania".

We need to coordinate the remaining screening of outfalls. Require access to University of Penn property.

# **PennDOT Highway Performance Monitoring System**

We completed the data for the requested roadways and sent to PennDOT on August 14.

# **Glenolden Park Waling Path Project**

We plan to complete the field survey later this year when the leaves fall.
