# MacDade Blvd. (SR 2006) over Bridge of Muckinipates Creek

Last reimbursement for engineering services was requested 3/7/15. We are gathering info for Borough to request 75% of fees. Sanitary sewer install is complete. PECO damaged a section of new sewer and we are working with Contractor to have corrected. We got email correspondence yesterday indicating they are removing the guiderail at Mr. Hart's property 425 Werner (Loftus Construction).

#### FY 2017 CDBG - Glenolden Park Trail

Contracts are being processed. A preconstruction meeting with Cleaver and OHCD is required prior to Notice to Proceed.

### FY 2018 CDBG - Lamont Park

\$179,993 was awarded by the County in their 2018 Action Plan. Next step in the process is to conduct kick-off meeting.

### **Glenolden Park – Lower Section**

Grant application was successfully submitted on April 17, 2018. The application was prepared to provide an accessible parking spot and ADA accessible path to the Lower Park.

#### Amtrak

I prepared a response to Amtrak's letter regarding "undocumented" facilities in their right-ofway. Amtrak's consultant acknowledged receipt and said they would be in touch if they needed anything else.

#### Aqua

Final roadway restoration for the S. Ridgeway Project.

We are following up with roadway rehab on Ashland @ Glen Circle.
