FY 2019 CDBG - Glenolden Park Walking Path - Phase 2

Solicitor's office reviewed the correspondence from the CSX Consultant and concluded we need the fencing if the trail stays in original proposed location or we can provide accessible route from Gardner and not complete the loop out to Knowles.

ADA Park Access

Project on hold, pending decisions on location. If the decision is to not proceed due to the impact on the tree, we need to formally notify DCNR..

MS-4

We submitted the annual report to DEP on September 29th. Letters were sent to several property owners requesting them to address deficiencies observed during our inspections of BMPs.

MacDade Signal Project

Work is progressing. They are installing conduits for the new signals. The widening of Oak should be completed in the Spring according to the schedule provided.

Academy Ave. Repaying

We spoke to the Ridley Township Manager and Township Engineer and mentioned the Borough may consider partnering with Ridley for repaving the road depending on further information such as costs and Council approval. It would be our recommendation to address the issues raised with the Academy Avenue bridge (below) prior to resurfacing. **NO CHANGE**

Academy and Hibbs Avenue Bridges

PennDOT representative Meg Sherman sent another email to Ridley Township and Darby Township requesting acknowledgement of ownership and responsibility for their proportionate share of costs associated with the inspection and maintenance of the Academy Ave. bridge. Upon their acknowledgement, Ms. Sherman suggested that the Borough acknowledge the change in ownership and it may prompt the others to do so for the cost sharing arrangement previously reported.

Lamont Park

It is our understanding that the Borough reached an agreement with JMC to address the cracking and ponding and to recoat the court.

Sink Hole 517 Harrison Ave.

We reviewed additional CCTV video and report information for the storm and sanitary systems provided by A to U. We reported to the Borough Manager that based on our review of the videos, reports and site areas, it appears there are no significant deficiencies with the Borough's storm and sanitary sewer systems that may have caused or contributed to the development of the sink hole. Based on our review and discussion with the Muckinipates Authority Engineer, it does not appear likely that the sanitary sewer interceptor that runs along the creek contributed to the sink hole.

119 Grays Avenue

We reviewed the Grading and Stormwater Application for a single lot residential construction and sent comments. Awaiting revised plans for the establishment of an escrow to cover construction and professional fees as discussed with the Borough Manager.

Chester Pike Corridor Study

We met with the Coalition on September 17th. We prepared exhibits, estimates and application documents for approximately \$40,000 for each community to install street signs, benches, planters and other amenities through the 5 municipalities focusing on South Ave, Glenolden Ave and Ashland Ave. intersections.

Mr. Puppio provided updated information to Council as it pertains to Borough litigation.

Mr. Puppio also advised Council as to how he feels they should proceed further in the process.
