# FY 2021 CDBG MacDade Boulevard Improvements

We prepared options for an artist's rendering. Based on input from the Council President we are updating the rendering and expect to complete by the end of this week.

#### South Ave. Bridge

I provided the 1930 map showing the sanitary sewer system on South Avenue under the bridge along with a request to the County consultant to provide justification for the Borough to pay for the relocation of the sewer when the work is required for the bridge reconstruction, not through any deficiency of the sewer. I have not received a reply. The Borough Manager has also been trying to obtain any basis from existing and former County employees.

# Glenolden – R - 119 Grays Ave

We notified the Borough construction commenced and we observed the work in progress at the site today.

We finalized the Year 3 report and sent to the Pennsylvania Department of Environmental Protection on 9/30/2021.

We are developing a plan of action and will present to the Borough with approximate costs that can be used for the 2022 budget. We are requesting that the Borough forward to us the TV videos and reports of the sanitary system A to U Services has taken which will help us with our cost estimate.
